

Claimants of PRC licenses are hereby advised to submit their Claim Stubs and Special Power Of Attorney (SPA) at least one (1) month before the scheduled service date. The deadline of submission is on October 23, 2015. To ensure a smooth and orderly conduct of the service, submission of application forms and other requirements is a must in the issuance of priority numbers. Releasing of PRC priority numbers will start on September 1, 2015 at the Bohol Employment & Placement Office (BEPO), 3/F Provincial Capitol Complex, Tagbilaran City.

It is hereby requested that the information shall be disseminated and coordinated within your respective divisions in order to maximize the service.
