CONTEST MECHANICS/GUIDELINES

1. Each Schools Divisions are encouraged to send representative/representatives for each contest categories;
2. The contestant must be a bonafide teacher of the schools divisions he/she represents;
3. The contestant is/are winner/winners of the elimination conducted in the recent division level competition. However, the Schools Division Superintendent may send contestant/s of his/her preference;
4. The following contest mechanics shall be observed:

4.1 Teacher Extemporaneous Speaking Contest

Topic: Anti-Violence against Women and their Children

- One contestant per Schools Division.
- Contestant is advised to read the Republic Act 9262: Anti-Violence against Women and Children Act.
- Each contestant will be given 10 minutes preparation and 5 minutes delivery.
- A green flaglet will be raised to signal the contestant to start his/her speech, a yellow flaglet at the last thirty seconds and a red flaglet at the end of the allotted time.
- Judges decision is final and irrevocable.

Criteria for Judging:

Presentation (50%)

Vocal delivery (25%): Pronunciation, intonation, pitch, tone, projection, articulation and pace should be considered and employed to convey the ideas, mood and argument of the speech

Manner of speaking (25%): The speaker should give the appearance of relaxed self-assurance and conviction. Movement, gesture and facial expression should reinforce the vocal delivery.

Content (50%)

Originality / Evidence / Information (25%): The judges will look for the speaker's ability to be original, to support arguments with evidence, and to supply information, with little preparation time.

Organization (25%): The speech should have a clear beginning, middle, and end. The judges will take into consideration whether the speech is introduced in an original fashion, how well the subject matter is organized, and whether it is brought to a logical conclusion.

4.2 Teacher Got Talent (TGT) Competition

- Each Schools Divisions may send individual or group entry (all teachers) with a maximum of ten (10 members)
- Each entry will run for at least 3 minutes and a maximum time of 5 minutes. One (1) point will be deducted from the total score from each judge for every minute or fraction thereof in excess or lack of the time allotted.
- Presentations should be wholesome and entertaining (STRICTLY no negative, no cross-dressing, no gay roles, e.g. Making fun of disabilities/ sexually suggestive actions, etc.) Non-compliance will result to disqualification.
- Costumes, props and musical accompaniment may be used to enhance the performance.
- Judges decision is final and irrevocable.
