**WARNING AGAINST UNAUTHORIZED TRANSACTIONS INVOLVING SCHOOL BUILDING
CONSTRUCTIONS**

1. DepEd Central Office, Assistant Secretary for Governance and Operations, releases an Office Memorandum giving precaution against unauthorized transactions involving school buildings dated September 2, 2016.
2. It is pertinent to note that there are malicious unidentified organizations around the different public schools offering donations, classroom buildings to schools in exchange of monetary payment by requiring the School Head to request such donation without following the school building program procedure.
3. Immediate dissemination of this memorandum is highly expected.



SUBJECT: *Warning Against Unauthorized Transactions Involving School Buildings*

DATE: 02 September 2016

It has been brought to our attention that malicious unidentified organizations have been making rounds in various regions, offering to donate classroom buildings to schools in exchange of monetary payment. The said donation will only require a request from the School Head and no longer need to go through the usual process of the national government.

Accordingly, please be conscious of such modus operandi and report these occurrences to proper authorities as well as this Office immediately. Please be reminded that the construction of school buildings and other similar programs shall be communicated through official letters or memoranda. When in doubt, kindly verify with the appropriate offices first.

For your immediate attention and strict compliance.
