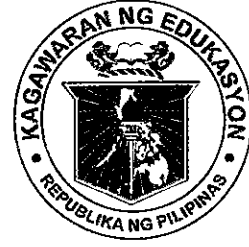

Consciousness Raising on Inclusive Education as Education for All Approach

TO: All Schools Division Superintendents
All Others Concerned

1. The Regional Education Development Plan for 2016-2018 emphasizes “Inclusive Education” for all types of children to be accessed in all Region 7 Elementary and Secondary schools regardless of typology or locations. To make it as a ready response for segmented learners like differently-abled, indigenous people, child laborers, children in conflict-ridden barangays, a three- day workshop, entitled: “Forging Sustainable Partnership for Effective Child Holistic Care” shall be initiated by Region 7 Office on July 25-27, 2016 in a venue to be announced later.
2. The participants to comprise the collective team from each division are enumerated in the Annex A. A PTA Federated President, a Municipal/ City Mayor or a Sangguniang Bayan/Panlungsod in charge of Education from the 13 Schools Divisions are invited in the first two days of the workshop to join the collective team in the organizational activities and development of the Division Child Care Operations Plan SY 2016-2018. Each Division shall bring a poster picture of children smiling/laughing, playing, eating, praying or working together. Tarpaulin maybe designed for the purpose. These pictures will be utilized as a photo gallery prior to start of the opening program on the first day.
3. The materials and kit for the holistic child care are personalized. They shall be paid by the seven participants on the list in the amount of 2,950php. This fund may be sourced from the school’s/division MOOE, HRDD funds, City School Board or SEF, or any available fund that can be tapped from the purpose. The accommodation and lodging expenditure shall be borne by the Regional Office. First meal shall be breakfast on July 25 and shall end with an afternoon snack on July 27, 2016.
4. Widest dissemination of this Memorandum is highly appreciated.

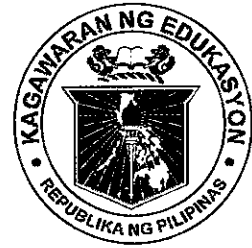
