CONTEST MECHANICS NATIONAL POSTER MAKING CONTEST

1. This contest is open to all Grades 7, 8 and 9 students enrolled in any public secondary schools nationwide. The school should be duly recognized by the Department of Education.
2. The theme of this year's competition is **"Pagmamahal Palaganapin, Legal na Pag-aampon Ating Gawin: Spread Unconditional Love Through Legal Adoption"**.
3. The contestant should submit ONE painting, using any medium, in a 15"x20" illustration board. Similar data should be placed in a ½ A-4 bond paper, computerized and be posted at the back of the painting:

Message (1 or 2 sentences only, written in Filipino)
4. The Philippine Flag should not be used as a background of the painting. If used as a part, it should be placed in a conspicuous place to show its importance to the art work. (Please refer to Sec. 39 – Prohibited Acts of RA 8491).
5. Criteria for Judging are as follows:

a. Message	40%
b. Visual Impact	30%
c. Originality	30%
Total	100%
6. All entries must be submitted to the Special Events Unit not later than **November 29, 2017 (Wednesday). Judging will begin promptly at 9:00 am on December 04, 2017 (Monday).** Each entry must be accompanied by the following requirements:
 - a. A certification from the school principal that the contestant is enrolled at the school in the current School Year (SY 2016-2017);
 - b. Scanned image, school ID, or any valid ID of the student and the principal; and
 - c. Accomplished entry form.

(Note: Entries with incomplete requirements will not be entertained/honored.)
