Teacher-participants and coaches shall be entitled to service credits in accordance with the provisions of Deped Order No. 53, s. 2003 while non-teaching personnel including the Kindergarten Program Management Staff and Organizers shall be provided with Compensatory Time Off (CTO) per CSC and DBM Joint Circular No. 2, s. 2004.
