2018 METROBANK-MTAP-DEPED MATH CHALLENGE

1. The Metrobank Foundation Inc. (MBFI), the Mathematics Teachers Association of the Philippines (MTAP), and the Department of Education (DepED) will hold the **2018 Metrobank-MTAP-DepEd Math Challenge (MMC)** from January to March, 2018.
2. The overall objective of the Competition is to contribute in improving the quality of Mathematics Education in the Philippines through the following:
 - a. awakening greater interest in Mathematics among elementary and junior high school learners;
 - b. encouraging them to strive for excellence in Mathematics;
 - c. discovering mathematical talents among them;
 - d. developing the values of hardwork, perseverance, honesty, teamwork, and sportsmanship; and
 - e. providing them with opportunities in leadership and cooperative undertaking.
3. The Division Elimination Round will be conducted on January 11, 2018 (Thursday) and January 12, 2018 (Friday) for the elementary level at Tagbilaran City Central Elementary School and junior high school level at Dr. Cecilio Putong National High School respectively.
4. Participating schools must accomplish a one page registration form (please find attached form) certified by the principal/registrar, indicating the school's official contestants and coaches/trainers per grade level. The accomplished form must be submitted to the DepEd Division Mathematics Supervisor on or before December 18, 2017.
5. The following schedule will be observed during the elimination round:
 - Grades 1 and II – (8:15 AM to 9:15 AM)
 - Grade III – (8:15 AM to 9:35 AM)
 - Grade IV – (10:00 AM to 11:20 AM)
 - Grades V and VI – (10:00 AM to 11:40 AM)
 - Grades VII to X – (8:15 AM to 10:15 AM)
6. Arrangement for substitute teachers must be made to ensure that the classes of the participating teacher-coaches will not be disrupted.
7. Immediate dissemination of this Memorandum is desired.
