**EXECUTIVE ORDER NO. 30**

Series of 2017

**RECONSTITUTING THE COMPOSITION OF THE CITY COUNCIL FOR CULTURE AND THE ARTS OF THE CITY GOVERNMENT OF TAGBILARAN**

**WHEREAS**, Section 204 of the 2007 Revised Code of Administrative Ordinances of the City of Tagbilaran mandates the creation and composition of the City Council for Culture and the Arts;

**WHEREAS**, the City of Tagbilaran has been in the limelight to local and foreign tourists and visitors coming to the Province of Bohol and is popularly known for its culture and arts history, development, achievement and contribution to the community;

**WHEREAS** to address the basic and immediate concerns pertaining to culture and arts attractions, history, development, achievement and its related activities in the City, there is an urgent need to reconstitute the composition of the City Council for Culture and the Arts;

**NOW, THEREFORE, I, JOHN GEESNELL L. YAP II, Mayor of the City of Tagbilaran, Bohol,** by virtue of the powers vested in me by law, do hereby order:

**SECTION 1. COMPOSITION AND MEMBERSHIP.** – The City Council for Culture and the Arts shall be composed of the following:

The Council shall elect from among its members the following officers: Chairman, Vice-Chairman, Secretary, Treasurer, and Press Relations Officer (PRO) and formulate its own internal rules and regulations.

**SECTION 2. POWERS AND FUNCTIONS.** -- The council shall exercise, but not limited to, the following powers and functions:

*Union City School District Resolution and Ordinance No. 2018-01*

- (1) Promote Culture and Arts;
- (2) Coordinate activities, projects and programs for the promotion of Culture and the Arts;
- (3) Seek and facilitate funding locally and abroad for the implementation of activities, projects and programs for the promotion of Culture and Arts;
- (4) Recommend measures to conserve, promote, and popularized our historical and cultural heritage and resources as well as artistic creations;
- (5) Recommend measures to give equal access to cultural opportunities through the educational system, public or private cultural entities, scholarship grants and other incentives, and community cultural centers and other venues;
- (6) Recommend measures to encourage and support researchers and studies on culture and arts;
- (7) Establish and maintain a city museum and city library;
- (8) Submit, during the first quarter of every calendar year, its plans of activities for the current year and render to the Sangguniang Panlungsod, within the two (2) weeks after the end of every calendar year, a written report about its activities and accomplishments for the immediately preceding calendar year;
- (9) Perform such other powers and functions as may be assigned by the City Mayor or by City Ordinance.

**SECTION 3. APPROPRIATION.** – The appropriations for the Council shall be provided in the regular and/or supplemental budgets of the City Government of Tagbilaran.

**SECTION 4. SESSIONS/MEETINGS.** – The Council shall hold sessions/meetings at least once every month.


**SECTION 5. OFFICE.** – The City Government shall provide an adequate office for said Council.

**SECTION 6. SEPARABILITY CLAUSE.** – If any provision of this Order shall be deemed invalid or unconstitutional, the remaining provisions thereof not affected thereby shall remain in full force and effect.

**SECTION 7. REPEALING CLAUSE.** – This Order repeals, amends or supersedes all existing local Executive Orders and other issuances inconsistent herewith.

**SECTION 8. EFFECTIVITY.** – This Executive Order shall take effect immediately upon signing thereof and shall remain in full force until revoked, repealed, modified or amended accordingly.
