The usual contribution per student and teacher is P 10.00 but an option to avail the Membership with Accidental Assistance Benefits with the Classic Membership Fee for students with the age range from 5-25 years old is P60.00. The local chapter will give back an incentive of P5.00 to the school per member who will avail the membership and 20% for the yearly contribution of P10.00 if remitted within the calendar year
