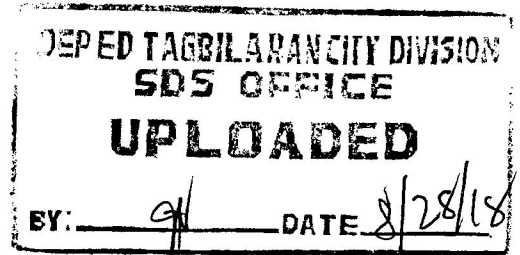

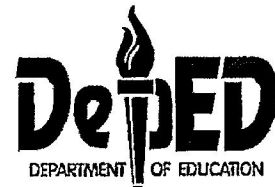

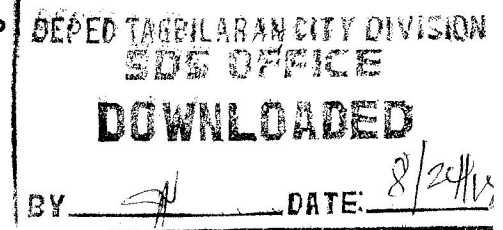

This Office through the Disaster Risk Reduction and Management (DRRM) Unit of the Education Support Services Division (ESSD) will conduct a Contingency Planning Workshop on September 5-7, 2018 to be held at DepED Applied Nutrition Center (ANC), Banilad, Cebu City, to enhance the crafted Disaster Risk Reduction and Management –Contingency Plan.
