ADMINISTRATION OF THE 2018 PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT)

To: OIC, Office of the Assistant Schools Division Superintendent

Heads of Public and Private Elementary and Secondary Schools

1. The Department of Education (DepEd) through the Bureau of Education Assessment (BEA) will administer the 2018 **Philippine Educational Placement Test (PEPT)** on *November 25, 2018* (Sunday) at Dr. Cecilio Putong National High School, Carlos P. Garcia Avenue, Tagbilaran City.
2. The PEPT is an equivalency test wherein learning experiences gained out of school are given equivalency and placement in the formal school system by grade level that is appropriate for the examinee's age and ability. This move will encourage him/her to continue and finish basic education and eventually to pursue senior high school if he/she so desires.
3. The target clientele of PEPT or those who may be qualified to take the test are learners:
 - a) from schools without a government permit;
 - b) from nonformal and informal education programs;
 - c) who have incomplete or no record of formal schooling;
 - d) who have back subjects;
 - e) who need grade level standards assessment; or
 - f) who are overage for their grade levels.
4. Registration shall be at the DepEd – Tagbilaran City Division Office, Second Floor, Old City Hall Building, Tagbilaran City until October 5, 2018 (Friday). Application Forms may be secured from the Division Testing Coordinator, Mr. John Ariel A. Lagura of the said office.
5. The requirements of each registrant are as follows:
 - a. **Accomplished Registration Form (PEPT Form 1);**
 - b. **Birth Certificate:** issued by the NSO or the Local Civil Registrar duly authenticated. Other documents can be accepted: Baptismal Certificate, Certification from the Barangay and a Joint Affidavit. Likewise, the provisions from the Memo on Learners with Special Needs are considered.
 - c. **School Records**
Elementary Level: Form 137 or Form 138
Secondary Level: Form 137
 - d. **ID pictures** (size 1" x 1"): two identical, recently taken preferably with name label and not scanned ID pictures with image proportionate to the size; to be pasted on the Registration Forms
 - e. **School Permit:** Photocopy of School Permit to Operate/Government Recognition (for applicants from Private Schools) – 1 photocopy for applicants coming from the same school.
 - f. **Registration Fee:** PhP 50.00

6. Prospective registrants are children and youth who are Filipino citizens and whose age and grade/year level completed are as follows:

7. On examination day, the test will start exactly at 7:30 a.m. Test Takers are advised to bring the Applicant's copy of the Registration Form, 2 pencils (lead no. 2), and snacks and lunch that they can eat during the break.

8. Board and Lodging of monitors from the Bureau of Education Assessment of DepEd Central Office will be charged against Division MOOE subject to the usual accounting and auditing rules and regulations.
