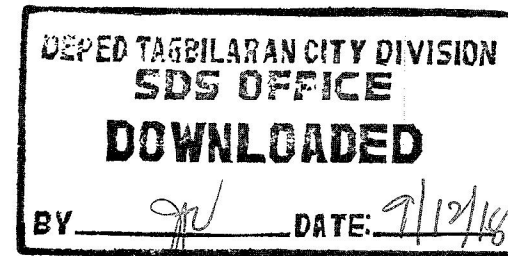

1. The Department of Education (DepEd), as mandated by Republic Act No. 9155 otherwise known as the Governance of Basic Education Act of 2001, undertakes and promotes the conduct of education research that will serve as one of the bases for necessary reforms and policy development.

2. In this connection, DepEd issued policy interventions that guide all governance levels to strengthen the internal processes and systems towards evidence-based decision-making. Specifically, the Policy Development Process DepEd Order (DO 13, s. 2015) provides for systematic, evidence-based and participatory mechanisms and procedures for formulation, adoption and review of policies issued by the Central Office. This policy is supported by the adoption of Basic Education Research Agenda (DO 39, s. 2016) that identifies research topics, which fill in critical knowledge gaps and respond to pressing concerns in Philippine basic education, consistent with DepEd vision, mission, and target outcomes, and in line with local and international developments in the sector. Also, the Research Management Guidelines (DO 16, s. 2017) is established to provide guidance in managing research initiatives at the national, regional, schools divisions, and school levels.

3. To further strengthen the culture of research and evidence-based decision-making, DepEd, in partnership with the Innovations for Poverty Action (IPA) Philippines, will conduct a bimonthly research forum, dubbed as **Research o'clock**. This forum seeks to:

- a. promote the use of research results and evidences in decision-making, program designing and implementation, plan formulation and adjustment;
- b. provide avenue for DepEd offices to learn from researches done by different sectors and organizations; and
- c. promote open discussions and continuous learning experience for education leaders, researchers, policy makers, and educators in

4. All DepEd personnel, research practitioners, research enthusiasts, policy makers, program managers, and individuals with interest in specific education issue or topic from different sectors are invited to attend the forum.

5. The following themes will guide the discussions in the succeeding Research o'clock sessions:

There will be two sessions—9:00–11:00 a.m. (morning session) and 1:30–3:30 p.m. (afternoon session) at the Bulwagan ng Karunungan, DepEd Complex, Meralco Avenue, Pasig City.

DepEd personnel's attendance in the forum must be approved by their immediate supervisor and participation of teaching personnel shall be subject to the no-disruption-of-classes policy stipulated in DO 9, s. 2005 entitled **Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith**. Transportation and other incidental expenses incurred shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.
