4. For guidance, information and compliance.

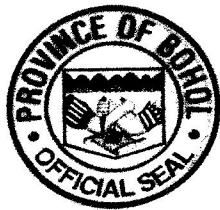

Warm greetings!

One of the very significant pre-requisites towards the buiding of the institutional foundation of the BOHOL INSTITUTE OF LIVING TRADITIONS (BILT) is the comprehensive cultural mapping in the province of Bohol. The output of this extensive research activity will be cultural profiles for each of Bohol towns. These will comprehensively describe the town's eco-cultural heritage features, spellout their various dimensions of significance, identify their status or condition, propose conservation measures and layout possibilities for economic development.

Ten (10) municipalities will be the pilot sites of the mapping activities this year and these are the municipalities of Albuquerque, Antequera, Baclayon, Balilihan, Catigbian, Cortes, Dauis, Loon, Maribojoc and Tagbilaran City. The rest of the towns in Bohol will be pursued in the nex two years.

We will be utilizing the UNESCO-NCCA mapping forms. And to ensure that this standard mapping tools will be optimized for our maximum benefit, members of the NCCA national Technical Working Group for cultural mapping will train a select group of BOHOL CULTURAL MAPPERS for five days. The training of local cultural mappers will be held at JJ Seafoods at the K of C on October 15-19, from 8:00 am-5:00 pm.

In this regard, I am requesting you to allow a DepEd representative from each of the city barangays to attend the five-days training. He/she should be previously trained in the recent Course in Cultural Mapping for Localization and Contextualization conducted for DepEd teachers by the NCCA.

This will be a very rewarding experience for teachers and an opportunity to take part in an internationally accepted process of doing cultural research. I am hoping that you will be our strong partner in this very noble endeavor.
