1. Relative to Regional Memorandum No. 830, s. 2018 entitled "2018 DepEd 7 Pasidungog" dated November 5, 2018, this Office issues the following clarifications:

- 1.1. **Teaching Experience for Outstanding Kindergarten Teacher**
Full-time teachers who have at least 3 consecutive years of experience in teaching kindergartens are eligible to participate.
- 1.2. **Qualifications/Eligibility Requirements for Outstanding Junior and Senior High School Teachers**
Nominees must have at least five (5) consecutive years of experience in the teaching profession including that of his/her experience from the HEIs, thus Performance Rating from the HEI will be considered.
- 1.3. **Item 6.3.**
Performance Rating (IPCRF/OPCRF for the last three (3) rating periods)

2. In relation to the required documents, the Division PRAISE committee may accept other documents that would attest the exemplary performance of the nominees.

3. All other provisions of the said Memorandum still remain.
