b. Financial Arrangement (On Part IV-Procedures, Letter F, Section 37)	The appropriate funds for the SDO-led and school-led orientation shall be downloaded to the respective regional offices.
c. Submission of Billing Statements and Other Relevant Attachments (On Part IV-Procedures, Letter F, Section 38, Item a to e)	The hard copies of Annexes 8A, 8B, 9 and 10 signed by the concerned authorities shall be submitted to the Office of the Director of the Bureau of Curriculum Development (BCD), while the soft copies shall be sent to email address: <a href="mailto:bcd.jdvp@deped.gov.ph">bcd.jdvp@deped.gov.ph</a> a week after the conduct of assessment.
d. End-of-the-program reports (On Part IV-Procedures, Letter E, Section 35, Item m)	The end-of-the program-reports, certified true and correct by an authorized representative shall be submitted to the concerned public school heads and school division offices through the JDVP-TVL coordinators, copy furnished the BCD through email address: <a href="mailto:bcd.jdvp@deped.gov.ph">bcd.jdvp@deped.gov.ph</a> a week after the conduct of assessment.

2. All other provisions of DO No. 33, s. 2018 remain in effect.
