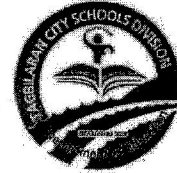

The Chess Arbiters Union of the Philippines-(CAUP) is a group of Filipino chess players who are holders of titles of International Arbiter, FIDE Arbiter, National Arbiter, Regional Arbiter and Club Arbiter duly-recognized and accredited by the National Chess Federation of the Philippines (NCFP) to officiate in chess tournaments and conduct arbitration seminars nationwide. The group whose members are mostly chess masters and strong club players also perform, on special occasions, chess clinics for beginners, intermediate and advance young players who wish to be more competitive in the game of chess.

In line with DEPED Memorandum Circular dated January 8, 2009 where chess is being included as one of the elective subjects in the *Edukasyon sa Pagpapalakas ng Katawan* to promote the development of higher order thinking skills and values among Grade 3 to 6 students and in the Physical Education classes of those in high school, we take this opportunity, therefore, to invite your respected School to send participants to our first **Chess Arbiters' Seminar** for this year on **February 12-14, 2019** prior to **Central Visayas Regional Athletic Association (CVIRAA) Meet** intended for public and private school teachers as well as professionals, chess coaches and chess players. This seminar will be held in Dumaguete City, Philippines.

Facilitators in this seminar will be **International Arbiter Patrick Lee** and other known chess personalities who will cover topics on (1) *FIDE Laws of Chess*, (2) *Regulations for Swiss System Tournaments*, (3) *FIDE Rating System*, (4) *Manual Pairing System*, (5) *Others (Tournaments, Tie-Breaks, Time Controls and Norms)*.

Participation fee is P2,500.00 per participant inclusive of handouts, certificates, snacks and seminar ID. As we envision to produce quality chess arbiters of world standards, we only limit 40 participants on a **first-come, first-served** basis for the seminar. Hence, we encourage participants to register early until **February 11, 2019**.
