- 1. This Office through the Curriculum and Learning Management Division (CLMD) will conduct Regional Training of School Heads and Teachers on Management and Supervision and on Contextualized Blocks of Time Cum Workshop on the Use of Ukulele as Accompaniment of Transition Songs on May 21-23, 2019 at DepEd Applied Nutrition Center, Banilad, Cebu City.
