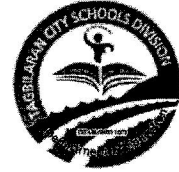

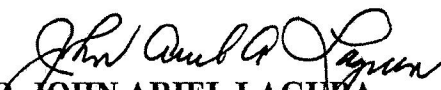

ENROLMENT QUICK COUNT FOR SCHOOL YEAR (SY) 2019-2020
