My daughter Margie Simborio was diagnosed with invasive Mammary Carcinoma (ICU) and is currently admitted at Perpetual Succour Hospital. She underwent chemotherapy and a major operation on her right breast last May 3, 2019. She is now on her 12th day radiation therapy for the prevention not to spread the cancer cells but the other she just suddenly felt ~~the~~ so much pain on her back which she cannot walk and even pain reliever is not effective so we've decided to admit her at the hospital. On the MRI result it has been seen that the tumor spread on her spinal. A 15 day Radiation Therapy started right away for the tumor.

At the moment I can no longer afford the hospital bills. My monthly pension is not enough to cover the hospital expenses as well as her medication/treatment. Any help is very much appreciated.
