**CREATION OF A TECHNICAL WORKING GROUP TO STUDY THE REGULATION
OVER CHURCH-BASED SCHOOLS IN BASIC EDUCATION**

1. Consistent with its mandate, the Department of Education (DepEd) exercises reasonable regulation over private schools. It issued DepEd Order (DO) No. 88, s. 2010, otherwise known as the **2010 Revised Manual of Regulations of Private Schools in Basic Education** and the amendments of its pertinent provision through DO 11, s. 2011 in order to operationalize its regulation over private schools and ensure quality basic education. As majority of church-based schools across regions have failed to meet the standards prescribed by existing policies, the United Association of Christian Educators of the Philippines-Luzon (ASCEP-Luzon) has requested the Department to study the regulation over church-based schools.

2. In this regard, a **Technical Working Group (TWG)** is hereby constituted to **Study the Regulation Over Church-Based Schools in Basic Education**. The following is the composition of the TWG:

3. The TWG is instructed to study and recommend the appropriate policy action relative to the regulation over church-based schools and to submit the optimal policy alternative not later than **December 31, 2019**.
4. The PS-PRD shall be the Secretariat to the TWG. Its functions include technical and administrative support to the TWG, and performance of other functions as the TWG may deem necessary.
