2019 DIVISION KINDERGARTEN DAY

GENERAL GUIDELINES:

- 1. Each school shall send one contestant in each contest category and only one contest shall be participated by each contestant.
- 2. Contestants shall wear the school uniforms during the contest except for Folk Dance Competition.
- 3. Coaches are not allowed to stay in the contest room and or in front of the stage during the performance of their contestants.
- 4. Mechanics in the conduct of the contest per category is to be followed strictly. The judges will agree on the deductions to be given for every violation on the mechanics of the contest.
- 5. The panel of judges shall be composed of a chairman and 2 members. The decision of the Board of Judges is final and irrevocable.
- 6. The first place winners of the division level contest will vie to the Regional Level Kindergarten Day on November 2019.

CONTEST MECHANICS OF THE DIFFERENT CATEGORIES:

1. MATHINIK (TANGRAMS)

- a. Contestants shall bring their own tangram materials with 7 geometric pieces.
- b. Each will be tasked to arrange the tangrams based on the given figure.
- c. There are 5 rounds to complete the activity.
- d. Contestant will be ranked according to the time they correctly finished the task.
- e. The contestant who will get the lowest composite time/ rank will be declared as winner.

2. MATHINIK (Arithmetic Wiz)

- a. The questions for this competition will be formulated from Window Card. (Addition/Subtraction)
- b. All participants will undergo the Window Card Exam.
- c. Each pupil will take the exam individually.
- d. No coach, faculty, staff or representative from any school other than the participants will be allowed to enter the examination room before the exam.
- e. Any questions during the exam should only be addressed to the proctors inside the room.
- f. Calculators, cellphones, or any gadgets will not be allowed inside the examination

- g. Only answer sheets, pens and window cards provided are allowed to be used during the exam.
- h. All contestants will be advised to take toilet breaks before the start of the exam. Once inside the room, pupils are not allowed to go out.
- i. Emergency situations will be handled by the proctors.
- Any form of cheating and intellectual dishonesty will result to the disqualification of the pupil.
- k. The top three (3) pupils with the highest score and fastest time will win.
- I. In case of a tie, the involved pupils will compete in a tie-breaker round to fill the remaining slots.

3. PICTURE READING

- a. The contestant will be given 5 minutes for acquaintance with the pictures.
- b. The picture story shall be delivered within 3 minutes.
- c. The language to be used will be Mother Tongue.
- d. The winners will be chosen by the panel of judges based on the general criteria below.

4. COLORING

- a. Each contestant will be provided with a copy of the pictures they will color using cravons.
- b. Contestants shall bring their own coloring materials (Crayons Kiddie Brand).
- c. The winners will be chosen based on the following criteria:

1.	Creativity	-	35%
2.	Neatness	-	25%
3.	Color Harmony	-	40%

5. VOCAL SOLO COMPETITION:

- a. Each contestant is free to choose any folk song and not a love song.
- b. Performance time is 2-3 minutes including entrance and exit.
- c. Minus-one music or live piano or guitar can be used as accompaniment; however, contestants are allowed to sing without accompaniment.

6. FOLK DANCE

- a. The group is composed of at least 4 pairs, 4 males and 4 females.
- b. Participants are given the freedom to choose any Folk Dance to be performed, but the suggested one is the "Carinosa."
- c. Time of performance should not exceed 5 minutes including entrance and exit.

7. BALAK

- 1. The contest is open to all public elementary schools. Each school is allowed to only have 1 participant/ contestant.
- 2. There will be only one piece to be used entitled "Ang Batang Pinangga" written by Mrs. Jenia Sumaylo.
- 3. Contestant should wear complete school uniform.
- 4. The decision of the Board of Judges is final and irrevocable.
