


Kids Parade of Nations
UN Costume Competition

Contest Mechanics:

1. The Kids Parade of Nations is open to all public and private schools Pupils ages 6 – 10 years old.
2. Participating schools must have 2 participants (*1 boy & 1 girl*) for the competition on October 20, 2019 at H&F Department Store of Alturas Mall.
3. School must submit a filled-out registration form to the MIS office of H&F Department Store- Alturas Mall. Deadline of submission of registration form is on October 15, 2019.
4. Each participant must be:
 - a. in full costume of the nation he/she is representing
 - b. holding a flag of the country he/she is representing
 - c. wearing a sash with the name of the country being represented
5. The Kids Parade of Nations will start at 2:00 PM on October 20. All participating schools must join the parade. Starting point is at CPG entrance going to 5th floor, then back to the event area.
6. After the parade, the participants will be introduced on the stage for presentation to the judges.
7. Prizes are as follows:

a. First Prize	P 8, 000 + Toys	(4,000 girl & 4,000 boy)
b. Second Prize	P 6, 000 + Toys	(3,000 girl & 3,000 boy)
c. Third Prize	P 4, 000 + Toys	(2,000 girl & 2,000 boy)
d. Consolation Prize	P 500 + Toys	
8. Criteria for judging:
 - a. **Adherence to country being represented - 30%**
 - *Is the participant wearing the appropriate costume of the country he/she is representing? Are all parts/items of the costume relevant and coherent?*
 - b. **Creativity - 30%**
 - *Mix and match of apparel and accessories which still adhere to the country being represented.*
 - c. **Effort- 20%**
 - *Intricacy of design; more accessories, more props, etc. - which augment the aesthetic aspect of the costume.*
 - d. **Overall Appeal- 20%**
9. Decision of the board of judges is final and irrevocable.
