1. To establish appropriate, relevant and inclusive Learning Delivery Modalities among the Schools Division Offices (SDOs), this Office will conduct a **Regional Kick-off on School Readiness for School Year 2020-2021 and the Region-wide Synchronized Simulation of the Enhanced Learning Delivery Modalities** on August 18, 2020 at 9:30 to 11:30 in the morning via MS Teams and FB Live Streaming to be hosted by DepEd Cebu Province Division.

2. The activity will showcase the different Learning Delivery Modalities (LDMs) used by the SDOs in the different key stages through a 10-15 minute video presentation per LDM. The **Region-wide Synchronized Simulation** by all the teachers will follow in the afternoon of August 18 until August 20, 2020 using the following (suggested) schedule:

August 18, 2020 pm – Key stage 1 (using contextualized SLMs)  
August 19, 2020 am - English and Filipino subjects (Key stages 2-4)  
August 19, 2020 pm – Math and Science subjects (Key stages 2-4)  
August 20, 2020 am – MAPEH and AP subjects (Key stages 2-4)  
August 20, 2020 pm – EPP/TLE and EsP subjects (Key stages 2-4)

3. Participants to the said activity are the Schools Division Superintendents/ Assistant Schools Division Superintendents, Chiefs of the Curriculum and Implementation Division and Schools Governance and Operations Division and the members of the Regional Working Committees.


4. Schools Division Offices are also requested to ask a 2-3 minute video presentation from their Local Government Unit Chief Executives (both the governor and city mayor). Submission of video from the Local Chief Executives and the video depicting the actual use of the LDMs will be on **August 14, 2020** through this link:
