**KAINANG PAMILYA MAHALAGA DAY**

1. This Office hereby disseminates Memorandum Circular No. 80 issued from the Office of the President of the Philippines, particularly paragraph 1, which states as follows:

*Pursuant to Proclamation No. 60 (s. 1992), which declared the last week of September of every year as Family Week and in order to afford government workers and their families time to celebrate, in their respective homes, the Kainang Pamilya Mahalaga Day pursuant to Proclamation No. 326 (s. 2012), work in government offices in the Executive Branch shall be suspended from 3:30 in the afternoon onwards on Monday, 28 September 2020.*

2. In compliance with such issuance, work in offices of the Department of Education (DepEd) Tagbilaran City will be **suspended from 3:30 in the afternoon today, September 28, 2020.**

MEMORANDUM CIRCULAR NO. 80


