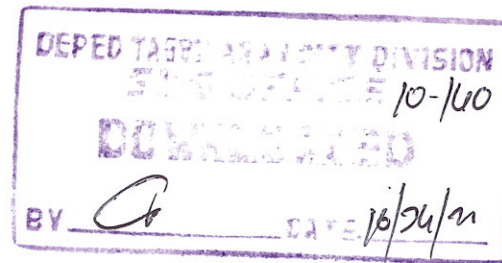

2020 NATIONAL CHILDREN'S MONTH CELEBRATION

1. The Department of Education (DepEd) joins the Council for the Welfare of Children (CWC), other government agencies, and the whole nation in celebrating the **2020 National Children's Month (NCM)**, also **the 28th NCM**, with the theme, *Sama-samang Itaguyod Ang Karapatan ng Bawat Bata sa Panahon ng Pandemya!*, this November 2020.

2. The celebration is pursuant to Republic Act No. 10661, titled *An Act Declaring the Month of November of Every Year as the National Children's Month*, which honors the ratification of the Convention on the Rights of the Child (CRC) by the United Nations General Assembly on November 20, 1989, and further articulates the importance of the CRC to the Filipino consciousness. It mandates DepEd to facilitate and to encourage the celebration of the NCM in all public and private schools nationwide.

3. This year's celebration will focus on upholding children's rights in the context of the COVID-19 pandemic. It aims to:

- a. intensify public awareness on children's rights, adequate care for children, and application of positive discipline in daily dealings with children;
- b. promote further the institutionalization of a child-friendly environment and governance by promoting implementation and monitoring of child-related protocols at the sub-national levels;
- c. provide a platform for discourse on persistent and arising issues pertaining to children's rights to survival, development, protection, and participation during and post COVID-19;
- d. build the capacity of children as rights-holders to claim and protect their rights; and
- e. build the capacity of duty-bearers to deliver their commitment and fulfill their obligations to protect children and fulfill the rights of children.

4. In view of the 2020 NCM celebration and this year's theme, DepEd Central Office (CO), regional and schools division offices, and all public and private

elementary and secondary schools, and attached agencies of DepEd are encouraged to undertake the following activities on the last week of October, and for the whole month of November:

- b. Upload of banner design on the website and social media pages;
- c. Conduct of livestream or posting of pre-recorded video recitation of the localized *Panatang Makabata* on the official websites and social media pages on November 03 as the scheduled NCM Kick-Off;
- d. Subscription to the Facebook Page of the CWC (www.facebook.com/CWCgovph) and Twitter account of CWC (@CWC_govph) by clicking the like and follow buttons to be informed on the various activities for children and adults;
- e. Posting/sharing of all materials on the CWC Facebook and Twitter Page to the respective agency/organizational social media accounts;
- f. Posting/sharing of all materials posted on the CWC Facebook Page;
- g. Participation in the webinar series and other remote/virtual activities of the NCM;
- h. In-class discussion of children's rights in relation to COVID-19;
- i. Conduct of remote/virtual activities related to the focus and theme of the 2020 NCM; and
- j. Submission of post-activity narrative report with photos to CWC on December 18, 2020.

5. In line with the foregoing celebration, DepEd CO will undertake the following activities:

- a. Conduct of the Second National Summit on the Rights of the Child in Education on November 12-13, 2020, with the theme, *Isulong! Karapatan ng Bawat Bata sa Edukasyon sa Panahon ng COVID-19*. Focusing on rights-based education (RBE) in the context of this Department's Basic Education-Learning Continuity Plan (BE-LCP) in the Time of COVID-19, the online Summit will gather children-learners, DepEd officials, personnel and teachers from public and private schools, parents of learners, and representatives from, among others, other government agencies, civil society

organizations, international organizations, private companies, and media. The Summit aims to:

- i. build on the gains of the First National Summit on the Rights of the Child in Education held in November 2019;
 - ii. reinforce the continuing commitment of the Philippine government, including DepEd, and other stakeholders in upholding rights-based education (RBE) in normal times and during the COVID-19 pandemic;
 - iii. facilitate discussions and elicit recommendations on upholding RBE in normal times and during the COVID-19 pandemic through a whole-of-DepEd, whole-of-government, and whole-of-society approach; and
 - iv. ensure the participation of children in shaping policies and actions pertaining to RBE in normal times and during the COVID-19 pandemic.
- b. Conduct of a Pre-Conference with Children Participants for the Second National Summit on the Rights of the Child in Education on November 6, 2020, to help the children participants prepare for the Summit, as well as to elicit suggestions from them regarding the conduct of the Summit.
 - c. Development and posting of collaterals pertaining to the promotion of the rights of the child in education and the celebration of the NCM, such as website/social media banners.
 - d. Issuance of stories and press releases written by children on the topic of their rights in the context of the BE-LCP; and
 - e. Implementation of social media campaign creating awareness on the rights of the child, with regular uploads to DepEd social media platforms of infographics using a child-friendly interpretation of the rights of the child, e.g., *karapatan mag-aral* (right to education), *karapatan makilahok* (right to participate and have one's views heard), and *karapatan maglaro* (right to play and leisure).

6. Materials related to the 2020 NCM will be uploaded and may be accessed in the **Advocacy** tab/section of the CWC website: www.cwc.gov.ph. The icon for the 2020 NCM and the *Panatang Makabata* are provided in Enclosure Nos. 1 and 2.

7. All expenses incurred by DepEd schools and field offices in the conduct of the activities celebrating the 28th National Children's Month shall be charged to local funds, subject to the usual accounting and auditing rules and regulations.

8. Schools and offices are requested to submit a report to document the activities undertaken by their respective units during the National Children's Month. Reports shall be submitted on December 18, 2020, to the CWC, through the CWC Secretariat, headed by Undersecretary Mary Mitzi Cajayon-Uy, CWC Executive Director.

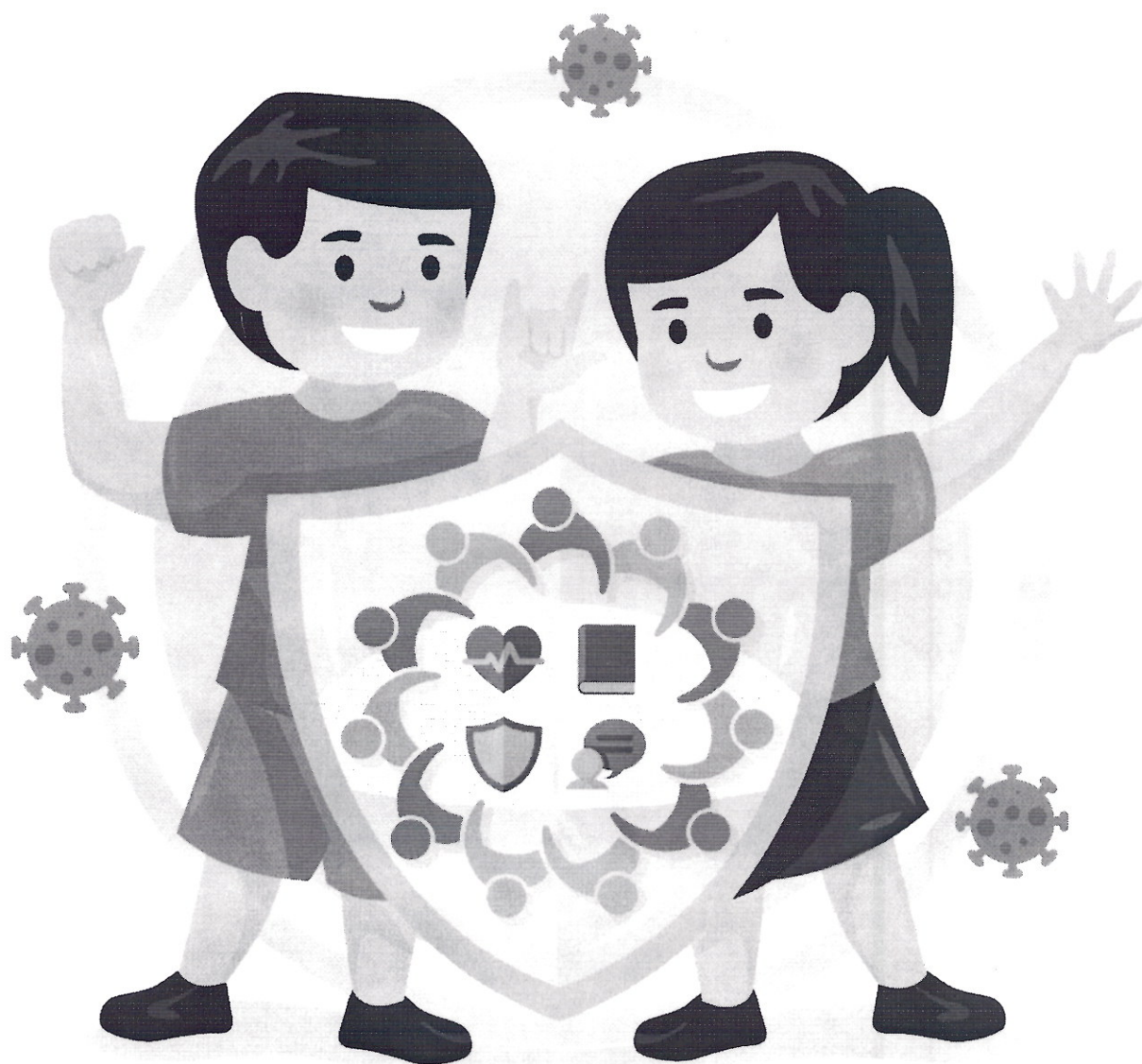
