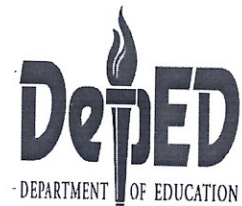

# Contract Agreement Form

THIS AGREEMENT made this \_\_\_\_\_ day of October, 2020 between the **DEPARTMENT OF EDUCATION, TAGBILARAN CITY DIVISION** (hereinafter called "the Entity") of the one part and **BOHOL STAR PRESS MARKETING, INC.** of 005 F. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
