The Department of Education, Tagbilaran City Division, through the CY 2019 Dental Health Facility Program intends to apply the sum of Three Hundred Forty Eight Thousand Two Hundred Thirty Three Pesos and Eighty Nine Centavos (Php 348,233.89) being the Approved Budget for the Contract (ABC) to payments under the contract for the Repair of Classroom/Conversion of Classroom to Dental Clinic at Tagbilaran City Central School SPED Center. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DepEd Tagbilaran City Division, now invites bids for the Repair of Classroom/Conversion of Classroom to Dental Clinic. Completion of the Works is required within the period of 60 Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from DepEd, Tagbilaran City Division and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm.

5. A complete set of Bidding Documents may be acquired by interested bidders on **January 13 to February 4, 2020** from the address below at **DepEd Tagbilaran City Division, Rajah Sikatuna, Dampas District Tagb. City** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Hundred Pesos (Php 500.00)**
6. The **DepEd Tagbilaran City Division** will hold a Pre-Bid Conference<sup>3</sup> on **January 23, 2020 10:00am** at **DepEd Tagbilaran City Division Conference Hall** which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **February 4, 2020 until 8:59am** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **February 4, 2020 9:00am** at **DepEd Tagbilaran City Division Conference Hall**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **DepEd Tagbilaran City Division** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
