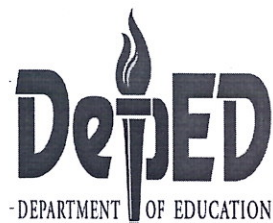

Contract Agreement Form

THIS AGREEMENT made this _____ day of October, 2020 between the **DEPARTMENT OF EDUCATION, TAGBILARAN CITY DIVISION** (hereinafter called "the Entity") of the one part and **5 ANGELS TRADING** of 004 Graham Avenue, Cogon, Tagbilaran City (hereinafter called "the Supplier") of the other part.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Nutri-Packs and other ready to eat Foods for School Base Feeding Program CY 2020-2021 at DepEd Tagbilaran City Division through the Government of the Philippines General Appropriations Act CY 2020 Basic Education Learning Continuity Plan Provision of Learning Resources 3rd Tranche Funds** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION SEVEN HUNDRED SEVENTY SEVEN THOUSAND SIX HUNDRED PESOS (Php 2,277,600.00)** (hereinafter called "the Contract Price").


