THIS AGREEMENT made this _____ day of October, 2020 between the **DEPARTMENT OF EDUCATION, TAGBILARAN CITY DIVISION** (hereinafter called "the Entity") of the one part and **5 ANGELS TRADING** of 004 Graham Avenue, Cogon, Tagbilaran City (hereinafter called "the Supplier") of the other part.


WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Twenty Thousand Reams of A4 Bond Paper Substance 20 at DepEd Tagbilaran City Division through the Government of the Philippines General Appropriations Act CY 2020 Basic Education Curriculum/Basic Education Learning Continuity Plan Funds** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **THREE MILLION EIGHT HUNDRED FIFTY THOUSAND PESOS (Php 3,850,000.00)** (hereinafter called "the Contract Price").

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

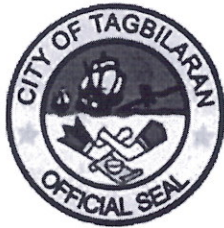

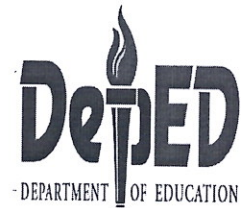
