3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

under Section 23.4.1.2 of the IRR of RA 9184 exists: Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from **DepEd, Tagbilaran City Division** and inspect the Bidding Documents at the address given below during Office hours (8:00am to 5:00pm).
5. A complete set of Bidding Documents may be acquired by interested Bidders starting **September 4-25, 2020** from the address below and upon payment in cash of a nonrefundable fee of the Bidding Documents in the amount of **FIVE THOUSAND PESOS ONLY (Php 5,000.00)**.
6. The **Department of Education, Tagbilaran City Division** will hold a Pre-Bid Conference³ on **September 14, 2020 @ 10:am at DepEd Tagbilaran City Division Conference Hall**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **September 25, 2020 until 8:59 am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **September 25, 2020 9:00am at DepEd Tagbilaran City Division Conference Hall**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **DepEd, Tagbilaran City Division** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
