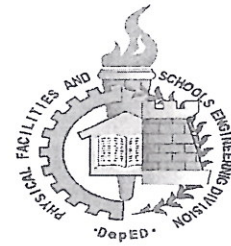

**REPRODUCTION AND DELIVERY OF MODULES FROM
KINDERGARTEN TO GRADE 11**

The Department of Education, Tagbilaran City Division, through the Basic Education Curriculum/Basic Education Learning Continuity Plan Funds intends to apply the sum of Fifteen Million Seven Hundred Thirty Thousand Five Hundred Forty Six Pesos (Php 15,730,546.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the **Reproduction and Delivery of Modules from Kindergarten to Grade 11 Fifteen Million Seven Hundred Thirty Thousand Five Hundred Forty Six Copies**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

SPECIFICATIONS:

*The size of bond paper to be used in the reproduction of modules should be A4 substance 20.

*The modules from kindergarten to Grade 2 should NOT be printed back to back.

The **Department of Education of Tagbilaran**, now invites bids for the **Reproduction and Delivery of Modules from Kindergarten to Grade 11 Fifteen Million Seven Hundred Thirty Thousand Five Hundred Forty Six Copies. Preferably Local Supplier with Printing Office at Tagbilaran City.** Bidders should have completed, within three years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

under Section 23.4.1.2 of the IRR of RA 9184 exists: Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Interested bidders may obtain further information from **DepEd, Tagbilaran City Division** and inspect the Bidding Documents at the address given below during Office hours (8:00am to 5:00pm).
5. A complete set of Bidding Documents may be acquired by interested Bidders starting **September 4-25, 2020** from the address below and upon payment in cash of a nonrefundable fee of the Bidding Documents in the amount of **TWENTY FIVE THOUSAND PESOS ONLY (Php 25,000.00).**
6. The **Department of Education, Tagbilaran City Division** will hold a Pre-Bid Conference³ on **September 14, 2020 @ 10:am** at **DepEd Tagbilaran City Division Conference Hall**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **September 25, 2020 until 8:59 am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **September 25, 2020 9:00am** at **DepEd Tagbilaran City Division Conference Hall**, . Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The **DepEd, Tagbilaran City Division** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
