**Subject: INVITATION FOR LEARNERS TO PARTICIPATE  
IN THE DRRMS OKKK! TAMBAYAN SERIES**

To prepare for distance learning for SY 2020-2021, DepEd, through the Disaster Risk Reduction and Management Service (DRRMS), Office of the Undersecretary for Legal Affairs (OULA) and the Youth Formation Division (YFD)—in partnership with Cultural Center of the Philippines (CCP), Komunidad X, and the Psychological Association of the Philippines (PAP)—conducted online learning activities to provide Mental Health and Psychosocial Support to learners, to orient them of their basic rights and help protect themselves during this pandemic.

This includes the **OKKK! Tambayan** (Online Kahusayan para sa Karapatan ng Kabataan Tambayan) designed to empower secondary learners and provide them a platform where they can share experiences at home and express their emotions and concerns amidst the pandemic through various art-based activities featured in different episodes.

Because these times remain a challenge to our learners, the DRRMS is continuing its online learning activities and online platform for high school learners where they may find a support system to cope with the new normal.

The relaunch of OKKK! Tambayan—renamed **OKKK! (Online Kahusayan at Katatagan ng Kabataan)**—aims to highlight student participation by inviting qualified and willing learners to apply as student panelists (please see Annex A for activity details, qualifications, and expected roles).

All DepEd offices are enjoined to 1) encourage high school students to join, and 2) assist in selecting qualified learners. Moreover, all high school learners are urged to participate in the actual run of the program which will start on January 2021 as a mental wellness series.

## ANNEX A

### Activity Details

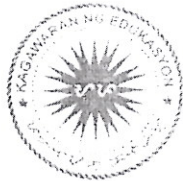
Thirty-four (34) students from all over the country will be selected to serve as pool of panelists for online discussions. That is two from each of the 17 regions.

### Qualifications:

1. Filipino enrolled in public Junior or High School, aged 14-18
2. Interested in advocating Mental Health
3. With good command of Filipino and English
4. Has a quiet space in the house to participate in Live sessions
5. Has confidence to speak before an online audience
6. Has enough bandwidth to participate in online video calls

### Expected Roles:

1. Selected students will undergo a series of trainings and workshops with Komunidad X weeks before the actual run of the program.
2. From the pool of 34 students, one (1) will be identified as a Host for each session of OKKK! and four (4) will be selected as Panelist for every episode. Participation will be rotated among the 34 panelists. Moreover, one (1) other student from the pool will be chosen to share his/her inspiring story related to the topics discussed at the end of each series. (OKKK! will be divided into 4 series.)
3. Selected participants are expected to commit to the following:
  - Synchronous and asynchronous community building activities/ Workshops by Komunidad
  - For the selected panelist of each week, they must attend 2 hours of “unpacking” session with Komunidad X, the professional speaker, and DepEd DRRMS-MHPSS Team
  - OKKK! episodes every Saturday, 4:00-5:30 p.m. via Zoom. The episodes will be livestreamed on Facebook through the official Facebook Page of the Department of Education.
4. Selected participants will be provided with a 10% Lead allowance by the DepEd Disaster Risk Reduction and Management Service (DRRMS).
5. Selected students must secure Parental Consent to participate. Should the student not be allowed, the Youth Coordinator is free to select a replacement.
6. Youth Coordinators must send the list of selected participants, along with their fully accomplished Parental Consent Forms (see Annex B), to the Youth Formation Division (YFD) of the Department of Education thru email at [blss.yfd@deped.gov.ph](mailto:blss.yfd@deped.gov.ph). Once fully received, the list will be submitted to the DRRMS-MHPSS Team by December 15, 2020.
7. The series will run from January 1, 2021 to January 31, 2021 every Saturday, 4:00-5:30 p.m., via Facebook Live and Zoom.
