



This pertains to the letter from PAG-IBIG fund Tagbilaran Branch dated December 18, 2020, regarding the problems encountered by DepEd Regional Payroll In-charge in remitting the monthly contributions as well as Short-Term Loan (Multi-Purpose Loan and Calamity Loan) amortizations due to Pag-IBIG Fund after the implementation of the Pag-IBIG New Telling System which started last November 2019. 
