The COVID-19 pandemic which has restricted mass gathering and travel has greatly affected the operations of Girl Scouting as mass physical/outdoor activities have temporarily stopped. But despite this, we have continued to implement and deliver our programs to Girls and Adults in the new normal with online activities, e-conference, and webinars through the different social media platforms. Girls still perform actual badgework or self-developmental activities at their own homes.

However, we sincerely need your help of continued support to sustain the existence of Girl Scouting in the province. To date, our record shows an overwhelming decrease in Membership – only 2% of Troops/Units, 2% of Barangay Committees, and 15% of District Committees are currently registered. The one-year membership have long expired already.

In this light, Bohol Girl Scout Council would like to appeal once again to its stakeholders (Parents/Guardians, Teachers, Schools-DepEd, Barangays/Districts-Local Government Units, Community) to re-register your Girls/Troops, Barangay Committees, and District Committees.



By-Law II, Section 5, defines Associate Members as "those unable to work actively with a Girl Scout group but who are interested in Girl Scouting".
