

With reference to DM-PHROD-2021-0010 entitled "*Guidelines on the Implementation of the Results-based Performance Management System (RPMS) for School Year (SY) 2020-2021*," the Bureau of Human Resource and Organizational Development - Human Resource Development Division (BHROD-HRDD) will conduct a three (3)-part live stream event which aims to orient field personnel on the adjustments made in the RPMS for teachers in the time of COVID-19, including its tools, processes, and protocols.
