In our effort to provide help in the continuous implementation of the Learning Continuity Plan, we will conduct **FREE Webinar for Parents** with the theme "*Promoting Family Engagement towards Students' Academic Excellence*". This is a 1.5 hour session designed for parents and guardians helping the young in their self-learning modules and other forms of distance learning modalities.

Rationale: The mental load of parents and guardians are significantly high today. Looking at the principles on gender division of labor, productive and reproductive work is difficult to balance especially during this pandemic. This formation session is designed to address this concern by creating awareness and providing helpful tools on family engagement in education.

50 mins. Presentation
25 mins. Open forum (Question and Answer)
5 mins. Session synthesis

We will be using Zoom App that can accommodate 500 guests. Thus, participating schools must ensure that their target audience have strong internet connection.
