86 The Presiding Officer acknowledged the presence of the interested
87 bidders and thanked them for their presence and participation of the project.
88 She also read the BAC activities prior to the opening of bids. The opening on
89 the Repair and Rehabilitation of Various School Building (14 classrooms) at
90 Ubujan Elementary School was conducted. Checking of the bidding documents
91 both technical & legal and financial documents was also undertaken.
92

93 After the examination of bid documents submitted, the BAC members
94 led by Dr. Casiana P. Caberte found out that C. Jansen Construction & General
95 Merchandise, ESP Design, Construction & Supply, JY Bontilao Construction &
96 Enterprise and Dolci Construction & General Merchandise were all eligibles for
97 the project.

99 Members of the BAC filled-up the form of Abstract of Bid as Calculated.
100

101 Dr. Casiana P. Caberte proclaimed C. Jansen Construction & General
102 Merchandise represented by Mr. Marlon R. Tan as the lowest and responsive

103 bidder to the Repair and Rehabilitation of Various School Building (14
104 classrooms) at Ubujan Elementary School.
