Bids received in excess of the ABC shall be automatically rejected at bid opening.



**under Section 23.4.1.2 of the IRR of RA 9184 exists:** Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.



7. The **Department of Education, Tagbilaran City Division** will hold a Pre-Bid Conference on **September 22, 2021 @ 10:am at DepEd Tagbilaran City Division Conference Hall**, which shall be open to all prospective bidders.
8. Bids must be duly received by the BAC Secretariat at the address below on or before **October 4, 2021 until 8:59 am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **October 4, 2020 9:00am at DepEd Tagbilaran City Division Conference Hall**, . Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
