1. This Office received a communication from PRC Cebu Regional Office, dated April 6, 2022, titled "**ACCEPTANCE OF CERTIFICATES WITH APPROVED CPD CREDIT UNITS**". This is in relation to the renewal of the Professional Identification Card (PIC).
2. It is reiterated that PRC Cebu Regional Office will **only accept certificates with approved CPD credit units**. This means that the webinar/seminar/training/workshop conducted by DepEd **was applied and was approved as a CPD program by the CPD Council for Professional Teachers through NEAP**.
3. Moreover, any in-service training/webinar/seminar/workshop that is non-CPD accredited will no longer be automatically accepted over the counter during the renewal of PICs. It will need to go through Post-Event accreditation first to be given with corresponding CPD credit units. The application for Post-Event accreditation is through the CPD Accreditation System.

Acceptance of Certificates with Approved CPD Credit Units

Dearest Ma'am and Sir:

One of the requirements for the renewal of the Professional Identification Card (PIC) is CPD credit units. The National Educators' Academy of the Philippines (**NEAP**), the training arm of the Department of Education, is already accredited as a CPD provider.

Hence, we would like to reiterate that we will **only accept certificates with approved CPD credit units**. This means that the webinar/ seminar/ training/ workshop conducted by DepEd (may it be conducted by school/district/division/ region) was applied and was approved as a CPD program by the CPD Council for Professional Teachers through NEAP.

Any in-service training/webinar/seminar/workshop that is **non-CPD accredited will no longer be automatically accepted over the counter during the renewal of PICs**. It will need to go through Post-Event accreditation first to be given with corresponding CPD credit units.

The application for Post-Event accreditation is through the CPD Accreditation System. The professional should create their CPDAS account. Submission of documents and payment are being done online too.

With this, we humbly ask for your assistance in disseminating this information to the schools and districts within your Division.

Should you want us to give more details regarding this matter, we can conduct an online orientation for CPD accreditation as well as the renewal process flow. You can send us a letter request addressed to our Regional Director for it to be scheduled.

We are looking forward to your positive response on the matter.
