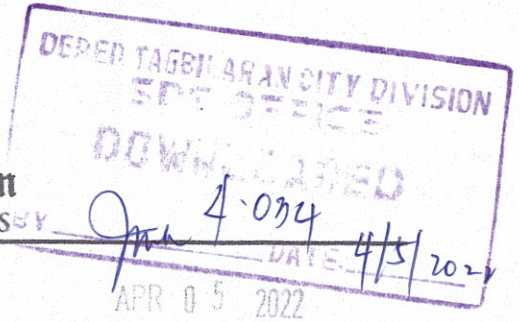

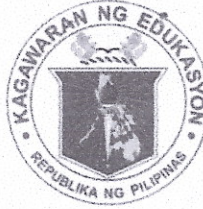

This Office disseminates the attached communication OUA MEMO 00-0422-012 dated March 17, 2022, entitled, the **Guidelines on the Utilization of Funds for the Cascading of the Foundational Course on Adolescent**. The Foundational Course on Adolescent Health aims to continuously support the provision of a responsive health care for adolescent and giving them a smooth transition to adulthood. Training for this Foundational Course was conducted last March 8-11, 2022 participated by the Regional and Division Adult Reproductive Health (ARH) Focal.

Subject: **GUIDELINES ON THE UTILIZATION OF FUNDS**
FOR THE CASCADING OF THE FOUNDATIONAL COURSE
ON ADOLESCENT HEALTH

To continuously support the provision of friendly and responsive adolescent health care, the Office of the Undersecretary for Administration (OUA) through the Bureau of Learner Support Services-School Health Division (BLSS-SHD) implemented the **Foundational Course on Adolescent Health**.

The same program shall be cascaded by the trained Regional and Division Adolescent Reproductive Health (ARH) Focal Persons to other DepEd teaching and non-teaching personnel, including all guidance counselors and designates in their jurisdiction within CY2022. Please note that the course materials shall be shared to ARH Focal Persons.

Kindly refer to the following guidelines on the utilization of funds for the cascading of the course:

1. The funds shall be utilized to support expenses in the conduct of virtual or face-to-face trainings (e.g., materials, food, honorarium of speakers, traveling, and venue or online platform).
2. The budget allocation per Regional Office (RO) and Schools Division Office (SDO) is P30,000.00. ROs shall sub-allot this amount to the respective SDOs.
3. ROs and SDOs are enjoined to augment for any other needs that may not be sufficiently covered by the downloaded funds.
4. As a core strategy of Oplan Kalusugan sa DepEd (OKD), forming of partnerships to support the conduct of activities is highly encouraged.



5. Related activities shall consider the current “new normal” set-up (i.e., no face-to-face classes, schools remaining physically closed for learners, distance learning, etc.), as well as the overall COVID-19 response of the Department such as efforts to promote vaccination.
6. All activities shall be made in accordance with the usual accounting and auditing rules and regulations.
