The box which contains the bid documents was closed at 8:59 in the morning with the presence of the Bids and Awards Committee and representatives from Sandugo Press Marketing and Supplies, Cebu Star Sales Marketing, Starbright Office Depot Inc., and 5 Angels Trading.

### A. Opening of Bids:

**1.** Supply and Delivery of (9,211) reams, (9,360) reams, and (26,454) reams of A4 Bondpaper Substance 20.

### VI. OPENING OF BIDS

 The Presiding Officer acknowledged the presence of the interested bidders. The opening of Bids for the Supply and Delivery of (9,211) reams, (9,360) reams, and (26,454) reams of A4 Bondpaper Substance 20, was conducted. The members of the BAC started checking the BAC documents (Checklist of Eligibility & Technical Financial Documents).

After the BAC Members examined the bid documents submitted, the Presiding Officer declared that the Sandugo Press Marketing and Supplies, Cebu Star Sales Marketing, Starbright Office Depot Inc., and 5 Angels Trading were all eligible for the supply and delivery of A4 bondpapers. The BAC Members then filled-up the form of Abstract of Bid as Calculated and as Read.

 The Presiding Officer declared that the Cebu Star Sales Mktg. represented by Mr. Renante G. Dalagan is the lowest and responsive bidder for the Supply and Delivery of (26,454) reams of A4 bondpaper substance 20 with an ABC of Php 5,026,260.00. Moreover, for the Supply and Delivery of (9,211) reams and (9,360) reams of A4 bondpaper substance 20, the Sandugo Press Mktg. and Supplies is the lowest and responsive bidder. After the declaration of the winning bidder, the Presiding Officer then excused the bidders from the BAC meeting.
