After the BAC Members examined the bid documents submitted, the Presiding Officer declared that the Global Copier Trading and Copier Source Enterprises were all eligible for the supply and delivery of A4 bondpapers. The BAC Members then filled-up the form of Abstract of Bid as Calculated and as Read.
