  - 3.3 **#STEMtokperiments** (A tiktok science experiment competition).(Submission of entries for Siyensikula and STEMtokperiments in flash drive will be on June 2, 2022, to Mr. Jesilo Jala, HT, DCPNHS.
4. The First-place winner in the different contest categories will be endorsed to the region for the screening and review of the submitted entries for the final selection of the top ten finalist. Announcement of winners will be released through a Division Memorandum.
5. Expenses relative to the conduct of the DSTF 2022 including honoraria of the judges and meals shall be charged against the Division MOOE subject to the usual government accounting and auditing rules and regulations.
