The Girl Scouts of the Philippines, Bohol Girl Scout Council is pleased to announce that after three years of no face-to-face large gatherings due to the COVID-19 pandemic, the Visayas Region will finally conduct its yearly regional camp once again.

Themed “**Girl Scouts: SHERvive as Trailblazers and Pathfinders in the New Normal**”, the **Regional Junior, Senior, and Cadet Camp** will be held on **April 27 to May 1, 2023** at the Marina Yulo Vargas Regional Program and Training Center (MYVRPTC), Barangay Kalunasan, Cebu City.

Hereunder are the pertinent details of said regional camp:

### **Campers**

- Girls: Junior - Four (4) Girls per Area  
Senior/Cadet - Four (4) Girls per Area
- Adults - Eight (8) Junior Troop Leader  
- One (1) Senior/Cadet Troop Leader

### **Qualification of Campers**

- Girls - must be registered Junior, Senior, and Cadet Girl Scouts as of June 30, 2023  
- must be physically fit and alert as certified by licensed physician  
- must have experienced/participated a school/district/provincial camp  
- must have earned at least one badge under the Challenge of Environment, Preparedness, Arts, and Heritage & Citizenship
- Adults - must be registered Troop Leader as of June 30, 2023  
- must have undertaken the Outdoor Leadership Course, and must be a Campcraft Certificate Holder  
- must have experienced/participated school, district, and provincial camps  
- must be physically fit to undergo the rigor of outdoor life  
- must know and understand her girls, and must know simple First Aid

## **Camp Fee**

Six Thousand Pesos (P6,000.00) per camper to cover for food, accommodation, transportation, insurance, program materials, souvenir kit, and tour.

The camp fee can be charged to the Division/School Maintenance and Other Operating Expenses (MOOE), Special Education Fund (SEF), District share of SMFC tickets, and local and other sources of funds subject to the usual accounting and auditing rules and regulations.
