We are pleased to inform you that the Samahang Tagapagtaguyod ng Kautubong Sayaw ng Pilipinas or the Philippine Folk Dance Society, the Cultural Center of the Philippines (CCP), and the National Commission for Culture and the Arts – National Committee on Dance (NCCA-NCD) will conduct the **2023 National Folk Dance Workshop from July 26-30, 2023 at Manuel Y. Torres Memorial Coliseum and Cultural Center, Bago City, Negros Occidental.**

The project will be conducted in partnership with the City Government of Bago City, Negros Occidental, the Philippine Normal University System, and Philippine Folk Dance Society Negros Occidental Chapter.

The workshop aims to:

1. Develop knowledge, skills, understanding, and appreciation for folk and traditional dances as bridges of cultures and people of the Philippines and Asia,
2. Upgrade competencies in teaching traditional Philippine dances among teachers, dance trainers, choreographers, directors, dancers, and dance enthusiasts,
3. Provide teachers with resource materials on dance such as dance books, music CDs, videos, hand-outs, etc., and
4. Hold a forum to discuss significant issues and concerns of folk dancers, dance teachers, trainers, choreographers, and workers of the arts & culture councils.

The 5-day workshop includes dance sessions, panel discussions, lecture demonstrations, fora, street dance, cultural shows, folk dance competitions, regional presentations, a city tour, and a culminating showcase of dances by all the participants.

In addition, the PFDS also forged a partnership with the Philippine Normal University to help us facilitate in the conduct of the workshop for Continuing Program Development or CPD points equivalency which is one of the basic requirements of Philippine Regulation Commission (PRC) license renewal among our teachers.

Invited to attend are dancers, teachers at all levels, dance trainers, teachers in charge of dance groups, directors, choreographers, members of dance groups, culture and arts officers & personnel, and cultural events coordinators.

persons, staff, performing groups, and other incidental expenses. Registration fee for students is **Four Thousand Pesos (P4,000)** upon presentation of an official valid student ID.

Participants shall take care of arrangements for transportation, accommodations, and meals. Assistance shall be provided for accommodation requirements on a first come first served basis in selected schools, dormitories, hotels, and other lodging areas in the city, especially for participants coming from the regions.

This Certificate grants juridical personality to the corporation but does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/ broker/merchant, financing company, pre-need plan issuer, general agent in pre-need plans and time shares/club shares/membership certificates issuers or selling agents thereof.
