1. Pursuant to Regional Memorandum No. 0281, s. 2023 and in preparation for the conduct of the 2023 Palarong Pambansa from July 29 to August 5, 2023 in Marikina City, the Department of Education (DepEd) Region VII will conduct a Regional Sports Training and Accreditation of the 2023 Central Visayas Regional Athletic Association (CVIRAA) identified Technical Officials and Winning Coaches this May 19 to 21, 2023. Accommodation of participants will be at Ecotech Training Center, Sudlon, Lahug, Cebu City while actual training and practicum will be at Cebu City Sport Center and Abellana National High school, Cebu City.

2. The training aims to orient participants on the new policies and guidelines on the return to sports: apprise them of how to shape safe and healthy playing environment; and provide updates on the current trends in sports coaching and officiating.
