Dear Director Jimenez:

This has reference to House Bill (HB) No. 2122 under "Batang Magaling Act", for which the Senate is requiring the bureau to submit immediately information on the list of taxpayers claiming deductible training expenses including amount as per Section 34 (A) (1) (a) (v) of RA No. 824, as amended by RA No. 11534 or CREATE LAW.

In that connection and pursuant to Section 5, par. B of the National Internal Revenue Code, as amended, in relation to Section 46 of RA No. 10173, otherwise known as the Data Privacy Act of 2012, may we request that this office be furnished with the **list of companies or establishments who accepted K to 12 Senior High School Students for skills development training during the year 2022. If possible, the list shall include the names of companies/establishments, the number of K to 12 students hired for training and such other available information relative thereto.**

We will be most grateful if the herein requested data can be made available immediately this morning as we are required by the Senate to submit today the information on claimed deductions of these companies/establishments.

Rest assured that whatever data or information obtained pursuant to this request will be treated strictly confidential and will be used exclusively for internal revenue tax purposes only.
