1. Proposed Repair and Rehabilitation of School Building (9 Classrooms) at Tagbilaran City Central Elementary School

After the Presiding Officer acknowledged again the presence of the lone bidder, C. Jansen Construction & General Merchandise represented by Mr. Marlon Tan, the bidding process then proceeded. The sealed envelopes of the bid documents were opened. The checking of the technical, legal, and financial aspects of the bid documents by the BAC Members was undertaken.

The Presiding Officer then announced after checking the documents that the bidder is eligible. The BAC Members proceeded then in filling out the form of Abstract of Bid as calculated.

Since, there was only one (1) bidder, the Presiding Officer then announced that C. Jansen Construction & General Merchandise, being eligible, automatically won the bidding for the Proposed Repair and Rehabilitation of School Building (9 Classrooms) at Tagbilaran City Central Elementary School with the bid/contract price of Three million five hundred eighty seven thousand ninety pesos and sixty seven cents (Php 3,587,090.67), Philippine currency.
