**APPROVING AND GRANTING THE REQUEST OF TAGBILARAN CITY TRICYCLE OPERATORS DRIVERS ASSOCIATION (TODA) TO PLY THE ROUTE FROM TAGBILARAN NATIONAL HIGH SCHOOL IN BARANGAY CABAWAN TO CITY SQUARE AND VICE VERSA WITH THIRTY-FIVE PESOS (P35.00) PROVISIONAL FARE RATE FOR REGULAR PASSENGERS AND THIRTY PESOS (P30.00) PROVISIONAL FARE RATE FOR STUDENTS, SENIOR CITIZENS AND PERSONS WITH DISABILITIES**

**WHEREAS**, Section 458 (a) (3) (vi) of the Local Government Code of 1991 confers upon the City Government through the Sangguniang Panlungsod the power to regulate the operation of tricycles and the grant of franchise for the operation thereof within its territorial jurisdiction, subject to the guidelines prescribed by the Department of Transportation;

**WHEREAS**, Section 16 of City Ordinance No. C-211 or the Ordinance Governing the Operation of Motorized Tricycles-For-Hire in the City of Tagbilaran provides that the "fare shall be established at a level that will provide the operator a reasonable return of profit and still be affordable to the general public";

**WHEREAS**, the Tagbilaran City Tricycle Operators Drivers Association (TODA) submitted Resolution No.1, Series of 2023, requesting Hon. Mayor Jane C. Yap through the Punong Barangay of Cabawan, Hon. Sergio M. Bangalao to allow their members to collect thirty-five pesos (P35.00) base tricycle fare for passengers plying Tagbilaran City Square to the newly-installed Tagbilaran National High School in Barangay Cabawan and vice versa;

**WHEREAS**, Ordinance No. C-274, Series of 2018 fixed the regular base fare for general commuters at ten pesos (P10.00) and for students, senior citizens and PWDs at eight pesos (P8.00) for the first kilometer with additional P2.00 for every succeeding kilometer or fraction thereof;

**WHEREAS**, due to increasing fuel prices, the 15<sup>th</sup> Sangguniang Panlungsod approved Resolution No. 22-139, Series of 2022, granting operators/drivers of motor tricycles-for-hire provisional authority to collect additional five pesos (P5.00) on existing regular (minimum) tricycle fare rate of ten pesos (P10.00) plus two pesos (P2.00) for every succeeding kilometer or fraction thereof as provided under Ordinance No. C-274, Series of 2018;

**WHEREAS**, the grant of thirty-five pesos (P35.00) provisional fare rate for regular passengers and thirty pesos (P30.00) provisional fare rate for students, senior citizens and PWDs is consistent with the above provision, considering that the distance between City Square and Tagbilaran National High School in Barangay Cabawan is almost ten (10) kilometers;

**NOW THEREFORE**, Be It Resolved, As It Is Hereby Resolved by the Fifteenth Sangguniang Panlungsod of the City of Tagbilaran in session duly assembled:
