IV. AGENDA OF THE MEETING

A. MAIN AGENDUM

1. Opening of bids on the Supply of Foods, Room Accommodation, Function Hall, Sound System, LCD Projector and White Board

After the Presiding Officer acknowledged the attendance of the lone bidder, the bidding process then proceeded. The sealed envelopes of the bid documents were opened. The checking of the technical, legal, and financial aspects of the bid documents by the BAC Members was undertaken.

The Presiding Officer then announced after checking the documents that the bidder is eligible. The BAC Members proceeded then in filling out the form of Abstract of Bid as calculated.

Since, there was only one (1) bidder, the Presiding Officer then announced that Bohol Tropics Corporation, being eligible, automatically won the bidding for the Supply of Foods, Room Accommodation, Function Hall, Sound System, LCD Projector and White Board, with the bid/contract price of One million nine hundred fifty thousand pesos (Php 1,950,000.00), Philippine currency.
